

Pet Care Agreement

This pet care agreement between Whiskers, Aquatics & Exotics LLC, (W.A.E.) (“pet sitter”) and _____ (“pet owner”) (Each “a party”, and collectively, “the Parties”) is made on the date of _____.

W.A.E. shall care for the pet owner’s pet(s) as identified and described below for the time period beginning _____ until _____. In consideration for W.A.E.’s care and services, the pet owner shall pay the pet sitter the full amount listed on the invoice upon completion of services. This payment can be made by cash, credit or check. Payment by credit card will have an additional 4% processing fee. For invoices totaling over or equal to the amount of \$500, half of the bill must be paid before the commencement of services, with the rest being paid upon completion of services. Late payments will be subject to fees of 20% of the bill for every week the payment is not received.

Care & Services Description & Frequency is outlined in the invoice signed by both parties.

The care and services will be provided in the home of the pet owner. The pet owner agrees to let pet sitter use the restroom facility/and or sink for pet sitting visits. The pet owner must provide a receptacle for disposal of pet waste on their property.

Emergencies

If there is an emergency Pet Sitter will make all reasonable efforts to first contact Pet Owner. If Pet Owner is unable to be contacted the Pet Sitter will contact the emergency contact number or veterinarian given in the new client questionnaire.

The pet owner authorizes the pet sitter to seek and obtain medical attention and treatment as deemed necessary by a veterinarian.

Injury & Indemnification

If Pet Owner’s pet(s) accidentally dies, becomes ill, injured, or lost, Pet Owner waives and releases pet sitter from any claim arising from such an incident. If pet owner’s pet(s) bites or injures Pet Sitter, any other human or animal, Pet Owner will be responsible for any resulting injury and shall hold harmless and indemnify Pet Sitter from any claim or suit that may be brought as a result of such an incident. In addition, Pet Owner shall hold harmless and indemnify Pet Sitter against any and all costs, expenses, losses, liabilities, and claims arising out of or relating to any acts of Pet Owner’s pet(s) except for negligence or intentional misconduct on the part of the Pet Sitter.

Governing Law

The terms of this agreement shall be governed by and construed in accordance with the laws and State of New Jersey, not including its conflicts of laws provisions. By signing this agreement, the owner states that he/she possesses the necessary permits for any exotic animals he/she owns.
